ADDENDUM TO
SOFTWARE LICENSE AGREEMENT

This Addendum Only Applies to STMicroelectronics' Software

This Addendum (the "Addendum") is hereby made to the Software License Agreement dated _____, _____ 2008 (the "License"), by and between _____ ("Customer") and Cray Inc. ("Cray"). Except as otherwise noted, all capitalized terms used herein shall have the meanings ascribed in the License.

In connection with Customer's desire to license from Cray certain Software produced by STMicroelectronics, Inc. ("ST") and listed in Exhibit A (the "ST Products"), the parties desire to modify the License solely with respect to Customer's use of ST Products by adding the following provisions:

Customer may neither (i) modify, adapt, translate, reverse engineer, de-compile, disassemble, or create derivative works in whole or in part based on the ST Products, nor (ii) rent, lease, loan, or electronically transfer the ST Products to others or from one computer to another over a network.

Customer will respect all intellectual property rights, copyrights, and patents that ST has in the ST Products.

Customer may make one (1) copy of the Products in machine-readable form, solely for archival or backup purposes, provided the copyright notice and other proprietary legends on the ST Products are included on any archival/backup copies made.

ST owns all right, title and interest in and to the ST Products and all intellectual property rights embodied in the ST Products, whether or not such ownership is specifically recognized or perfected under the laws of any jurisdiction.

THE ST PRODUCTS ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, ST AND ITS LICENSORS AND SUPPLIERS FURTHER DISCLAIM ALL WARRANTIES, INCLUDING WITHOUT LIMITATION ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NONINFRINGEMENT. THE ENTIRE RISK ARISING OUT OF THE USE OR PERFORMANCE OF THE ST PRODUCTS AND DOCUMENTATION REMAINS WITH CUSTOMER AND CRAY. IN NO EVENT SHALL ST OR ITS SUPPLIERS OR LICENSORS BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, INDIRECT, SPECIAL, PUNITIVE, OR OTHER DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION, LOSS OF DATA OR OTHER PECUNIARY LOSS) ARISING OUT OF THE LICENSE OF THE ST PRODUCTS TO CUSTOMER AND CRAY OR THE USE OF OR INABILITY TO

USE THE ST PRODUCTS, EVEN IF ST OR ITS SUPPLIERS OR LICENSORS HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

The foregoing provisions shall apply solely to Customer's use of ST Products. Customer's use of all other Software licensed by Cray shall be governed by the original terms of the License. Except as expressly amended hereby, the License shall remain in full force and effect in accordance with its terms.

CUSTOMER AND CRAY AGREE TO THIS ADDENDUM AND THE FOREGOING TERMS AND CONDITIONS.
